



Undantag från flaggningskyldigheten beviljade av Finansinspektionen

Finansinspektionen har sedan den 1 augusti 2007 beviljat följande bolag undantag från flaggningskyldigheten med stöd av 2 kap. 11 § i värdepappersmarknadslagen. Undantagen gäller fondbolag, fondföretag och värdepappersförmedlare för vilka anmälan om tillämpning av undantag inte kommer i fråga, eftersom de har verksamhetstillstånd i ett land utanför Europeiska ekonomiska samarbetsområdet. Finansinspektionen kan dock också i sådana fall bevilja undantag från flaggningskyldigheten om undantagsvillkoren i 2 § 4 och 5 mom. och 8 § i finansministeriets förordning uppfylls..
