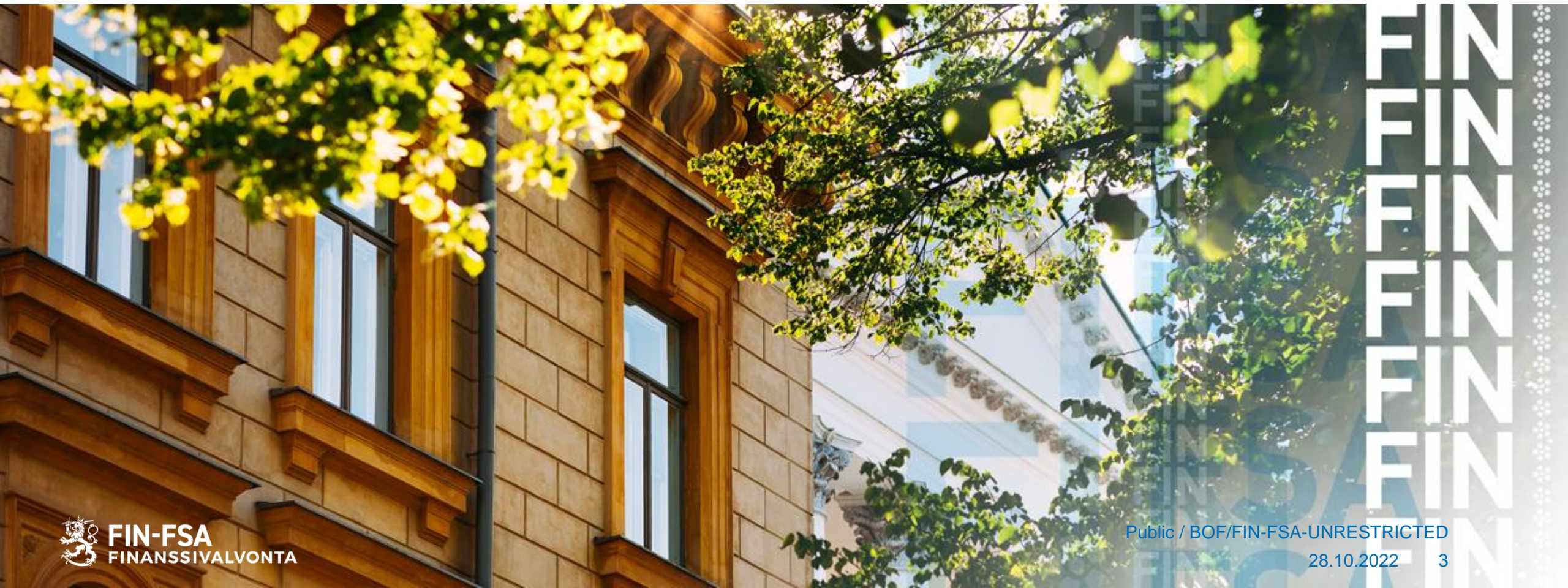

EBA DPM 3.2 changes to reporting

- The implementation of DPM 3.2 will be delayed for the following data collections
 - COREP OF (own funds)
 - COREP ALMM (Additional Liquidity Monitoring Metrics)
 - AE (asset incumbrance)
 - G-SII (Supplementary reporting for identifying and assigning G-SII buffer rates)
 - IF CLASS2 (Class 2 reporting of investment service providers)
 - IF CLASS3 (Class 3 reporting of investment service providers)
- Four-digit numbering for row and column numbering
 - now for AE and COREP ALM

EBA DPM 3.2 changes to reporting

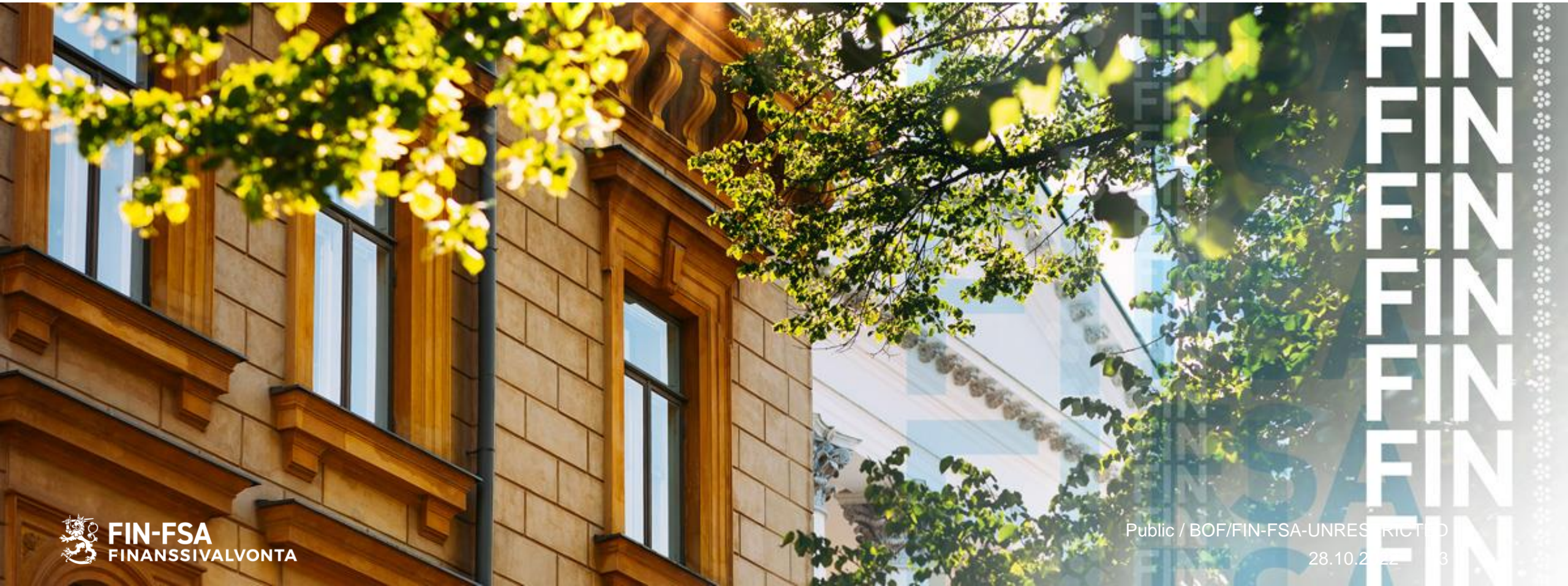
- With DPM 3.2, CON and IND naming of modules (reports) is removed
 - The information is included in the report itself
 - Further information in the [EBA Filing Rules](#) document, version 5.1
 - The change will take effect from reference date 31 December 2022
- When reporting to the FIN-FSA, please take into account the FIN-FSA's guidelines: [Description of machine-language data transmission of XBRL format reports \(EBA and EIOPA\)](#)

What to expect?

- In the following reporting publications:
 - Interest rate risk reporting IRRBB (interest rate risk arising from the banking book)
 - [EBA Guidelines](#) published 20 October 2022, for consultation in early 2023
 - FRTB reporting (for consultation this year)
 - IFRS changes will possibly be reflected in future publications for FINREP reporting
 - ESG risk reporting
- In the next few years, the requirements brought by CRR3/CRD 6 will bring more significant changes to reporting

Justifications for introduction of Suomi.fi services

- [Act on support services for shared government electronic services \(571/2016\)](#)

“Section 1 Purpose and scope of the Act

The purpose of this Act is to improve the availability, quality, information security, interoperability and management of public services and to promote the efficiency and productivity of public administration activities.”

- Regulates the provision, use and service-specific matters of Suomi.fi services
- As a general rule, public administration organisations have an obligation or right to access the services
- The private sector has the right to access certain services
- [Decree of the Ministry of Finance supplementing the Act on support services for shared government electronic services \(607/2016\)](#).

Suomi.fi e-Authorisations service

- [Suomi.fi e-Authorisations service](#) ensures that, when reports are submitted through the Reporter Portal, the reporter has the right to represent the entity that the report concerns;
 - The reporter must have a mandate from the reporting entity to make reports
- Mandates to individuals making reports may be granted by a person who has the role of representing the entity in a basic register or in the authorisation register.
 - Basic registers: Trade Register, Business Information System and Register of Associations
 - Example: the CEO of a reporting entity grants mandates to the employees responsible for reporting
- [Mandate service provided by officials](#): If the basic register information of an entity does not allow granting of mandates, the entity may apply for mandates to be entered in the authorisation register.
- Examples: There are no representatives entered in the Trade Register for an entity; all representatives of the entity are foreign persons; foreign company (no Finnish business ID)

Suomi.fi e-Identification

- Logging in to the Reporter Portal requires strong identification through the Suomi.fi e-Identification service
 - Login requires: personal means of identification, mandates and reporting obligations in the portal to the entity on whose behalf the person is reporting
- Reporters log in with their personal means of identification
 - When the reporter must have a Finnish personal identity code online banking codes, certificate card or mobile certificate
- UID and Finnish Identification Service: If the person responsible for reporting does not have a Finnish personal identity code, then they must register themselves for a foreign identifier (UID)
 - Granting mandates also requires the recipient to have a Finnish personal identity number or UID

Practical instructions: Mandate specifier

- Mandate theme: Reporting of financial standing and risks
- Mandate specifier
 - For each mandate theme, it necessary to specify which data collection the mandate concerns. A mandate that has not been assigned a specifier cannot be used in the Reporter Portal
 - With the specifier “ALL”, the mandated individual is able to report all data collections concerning the entity
 - With a specifier for a specific data collection, mandates can also be granted for individual data collections
 - Based on data collection codes, e.g. COREPOF, FINREPIFRS, IFCLASS2
 - A list of data collection codes can be found in both the [financial sector](#) and [insurance sector](#) reporting maps

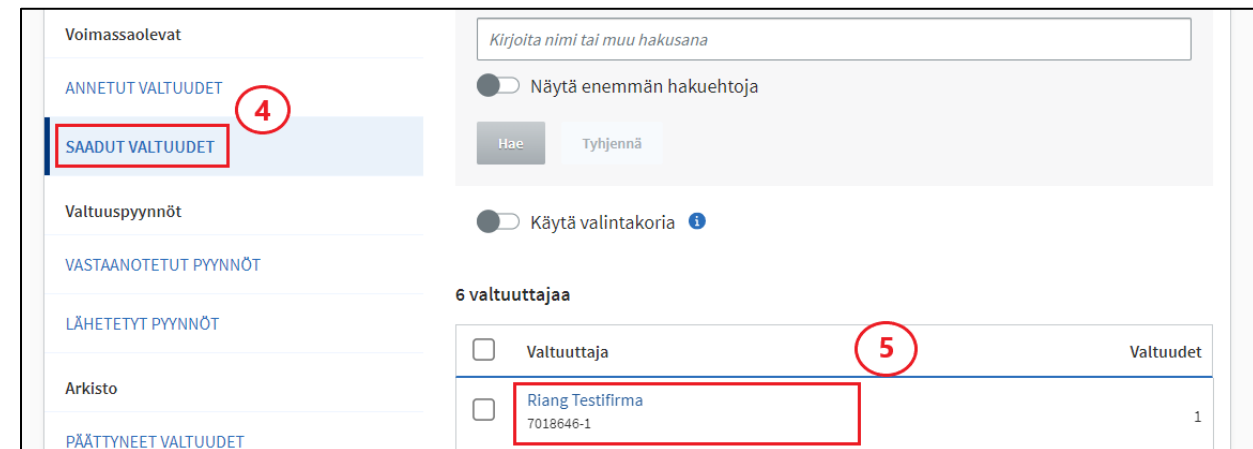
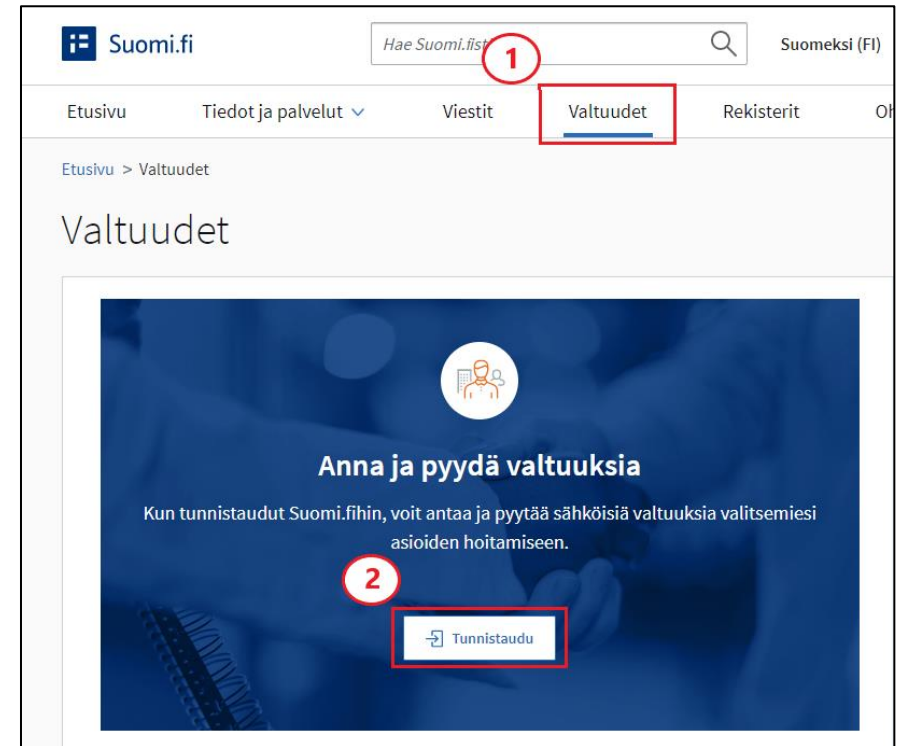

2. Log in with a personal means of identification
3. Select 'Personal mandates'
4. On the personal mandates page, select 'Received mandates'
5. Select the entity from which you have mandates that you wish to check

Mandate specifier ALL or data collection-specific specifier according to data collection maps

Mandate type is one of the following:

- Mandate for transactions
- Mandate to represent

Schedule for introduction of Suomi.fi services

- Reporting entities may grant mandates to reporters before the introduction of the Reporter Portal
 - The Reporter Portal's mandate for transactions can be found in the e-Authorisations service
- Check the [FIN-FSA website](#) for when the first data collection reported by your entity will move to the Reporter Portal
- Determine which individuals in your entity have the right to represent the entity/are authorised signatories, and who are authorised to act on behalf of your entity
- If the entity does not have any individuals who have right to represent the entity and who it could authorise on its own in the Suomi.fi e-Authorisations' service, then the entity must make a mandate application in the mandate service provided by officials.
 - **Please note. The processing time is 4-6 weeks**
- We recommend that entities begin the authorisation process 2 months before the entity submits reports via the Reporter Portal for the first time

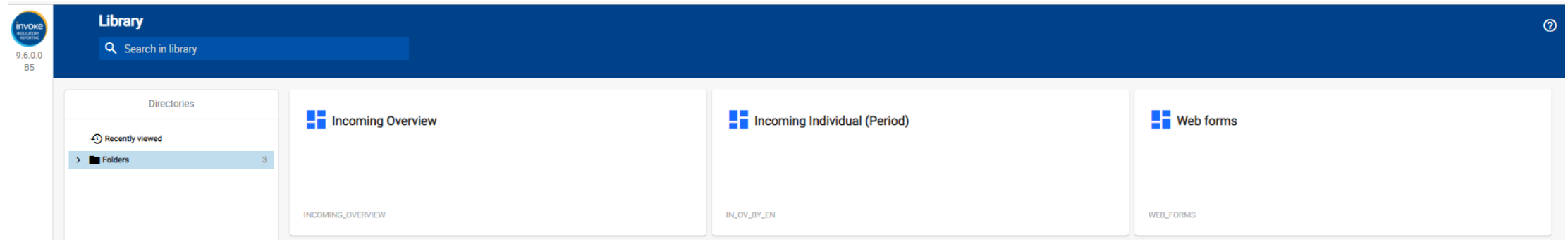

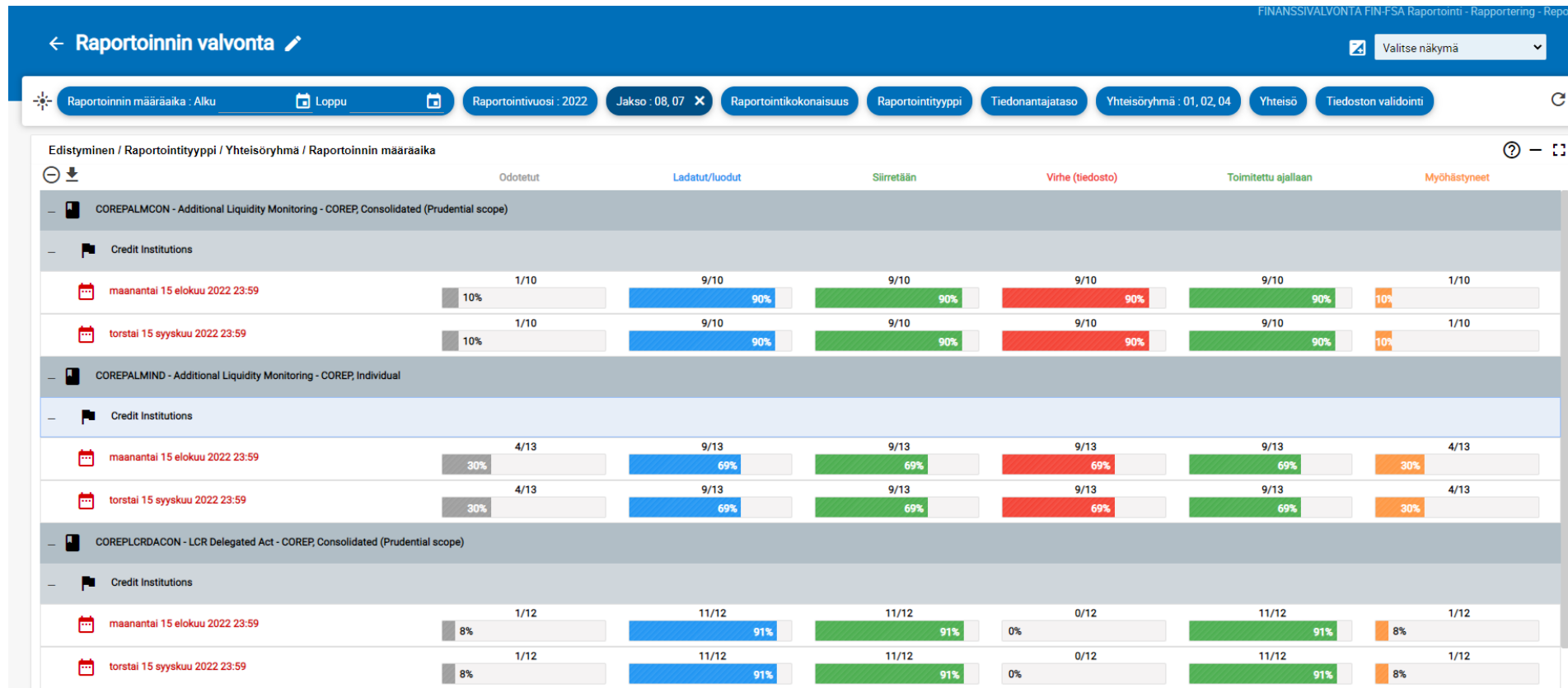

Reporting monitoring display

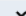







- Overall reporting situation by data collections and deadlines

- Clicking the colour bars opens up monitoring display for individual reports, where e.g. selected invalid reports have been pre-filtered

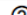
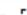
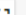

Reporting forms

- Reports can also be submitted using manually completed forms
- It is recommended that reporting forms only be used with a small number of forms
- It is possible to copy a previous report version as a template for a new report
- Forms can be exported to Excel for filling and brought back to the Reporting System
- Using a form: Create > Enter information > Save > Validate > Approve

Approving a report for submission to the FIN-FSA

- Finally, the report made using reporting forms must be approved in order for it to be sent to the FIN-FSA
- Only a complete report can be forwarded
- After approval, the report is transferred for processing and can no longer be edited

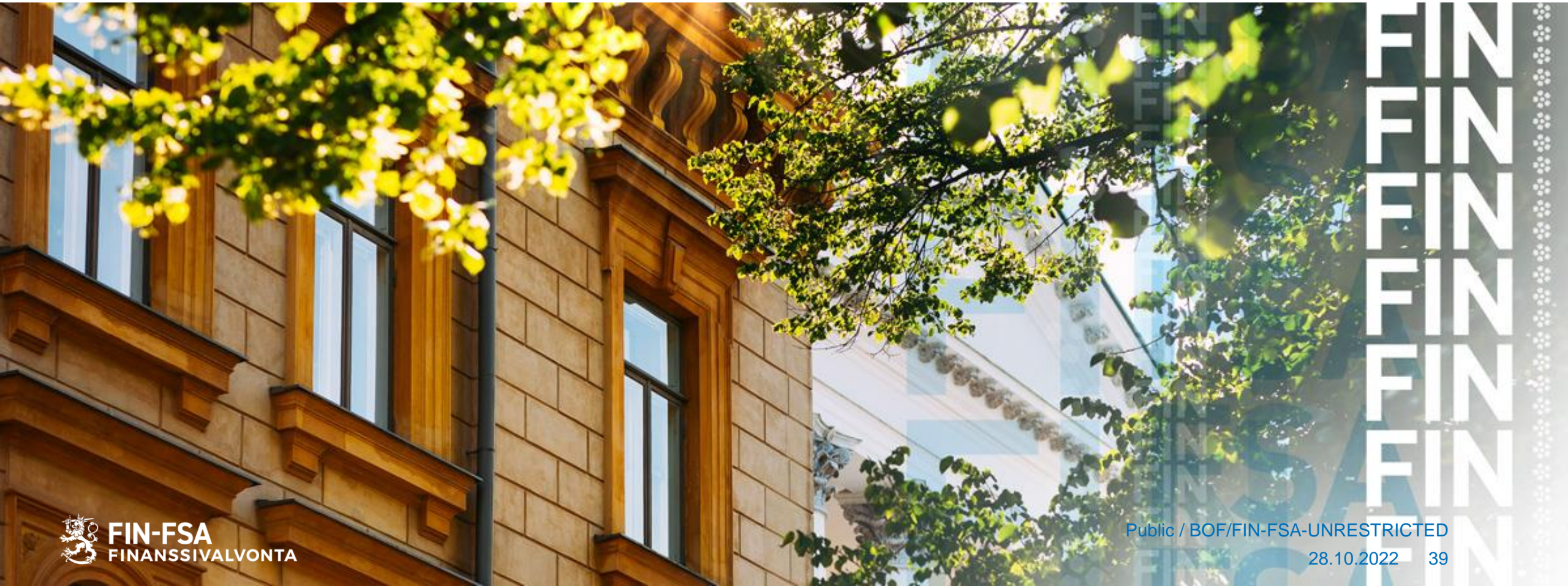
